- 7. Incase of authorized dealer, bidders are required to submit Bid Specific OEM Authorization Certificate / Manufacturer Authorization Form (M AF)
- 8. Buyer reserves the right to place supply orders after ascertaining the quantity as per actual requirement
- Bid shall be evaluated on the basis of Total wise evaluation method. However the Sanction Order shall be placed in favour of L1 after ascerta
 ining the reasonability of prices to confirm the bid is balanced.

2.9 Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 3 years before the bid opening date. 2.17 Past Project Experience:

(i) Single order of at least 35% of estimated bid value; or

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
