iii. Seller shall be responsible for ensuring that the plant/tree saplings supplied are in the same condition as depicted in the listing on GeM platform.

iv. Seller shall ensure that all saplings supplied as per the specifications as stipulated in the order in terms of height, growth and age.

v. Seller shall replace the saplings of plants/trees that go dry or die out, at no additional cost to the buyer

vi. The supplied plant/tree saplings shall be placed by the seller at the designated location within the buyer's campus/premise as directed by the buyer.

vii. The cost of all material, cartage, conveyance charges etc. shall be borne by seller for carrying plants from nursery to buyer location and vice versa.

viii. Seller shall ensure that no saplings supplied are damaged in transit from nursery to buyer's location.

ix. In order to maintain the freshness and health of supplied plants Seller shall ensure that supplied plants are maintained by professional gardener.

x. Gardener shall visit at least once in a week or as and when required to carry out upkeep of supplied plants. (Optional)
