OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The						

purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2.2 Buyer Added Bid Specific ATC:

Instruction :

- 1.0 The items shall be supplied as per the specification enclosed.
- 2.0 Make: FINOLEX/UNIVERSAL/RPG(ASIAN)/CCI/NICCO/FORT GLOSTER.
- 3.0 Detailed technical specification necessary catalogue shall be sent along with the offer for the quoted item.
- 4.0 The cable should be supplied in non-returnable cable drum of single length of 500Meter with +10% tolerance in length.
- 5.0 Guarantee certificate and test certificate are to be sent along with the supply.
- 6.0 The bidder shall offer the price on "F.O.R Salem Steel Plant" basis in GeM portal including P&F charges, Freight & Insurance Charges etc with applicable taxes & duties.
- 7.0 The payment shall be "100% within 30 days after receipt and acceptance of the item at Salem Steel Plant Stores".
- 8.0 Unless otherwise specified in the tender terms, the inspection will be at Salem Steel Plant after receipt of the consignment.
- 9.0 The bidder shall not quote/attach any price/price bid format along with their technical offer. The offer of such bidder will be summarily rejected.
- 10.0 The MII/MSE preference's shall only be given to bidders subject to submission/verification of valid MII certificate/Udhayam Certificate.
- 11.0 The prices shall be kept firm till supplies are completed.
- 12.0 The bidder shall enclose signed and sealed copy of the technical specification, as a token to acceptance to the tendered item's specification.
- 13.0 Delivery Schedule: 08 weeks from the date of order placement.
- 14.0 The applicable EMD amount is Rs.5,000/- (Rupees Five Thousand Only). In lieu of EMD, bidders can submit "Bid Securing Declaration duly signed & sealed. MSME bidders are exempted from EMD subject to submission of Udyam Registration / NSIC Certificate.
