### 1. General Terms and Conditions-

1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.

The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. #### 2.2 Certificates:

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 2.3 Scope of Supply:

Scope of supply (Bid price to include all cost components) : Only supply of Goods

#### 2.4 Buyer Added Bid Specific ATC:

Buyer Added text based ATC clauses

1. Specifications compliance with required items should be submitted on letter head of bidder duly signed by authorized signatory of bidder.

2. No alteration in make and model allow after technical evaluation.

3. Bidder must ensure that the supplied item is in compliance with latest Bureau of Indian Standards certification (BIS/ISI) or its equivalent.

4. Bidder must ensure to provide in-house testing report or test report of any Govt authorised laboratory at the time of supply.

5. If any item /batch of item declared as NSQ (Not of standard Quality). Recall the NSQ item immediately from Hospital/Buyer and bidder is liable to pay compensation/damage (if any) due to NSQ item.
