1. General Terms and Conditions-

1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.

1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or Bid/Reverse Auction Additional Terms and Conditions (ATC), as applicable

2. Buyer Added Bid Specific Terms and Conditions-

2.1 Generic:

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2.2 Buyer Added Bid Specific ATC:

2.Bidder Must have Submit BOQ Compliance of technical Specification

3.Affidavit required by the bidder stating that the bidding firm has not been black listed by any

Central/state Government Authority/Department as on bid Effecting dates

4.It will be Mandatory for the bidders to attach a non-judicial stamp paper of Rs.100/- with a receipt

stamp of Rs.1/- for the prescribed validity with the tender

5.It will be Mandatory for the bidders to give an affidavit on Rs.100 & Rs.10/- non-judicial stamp paper

6.LaborCESS at the rate of 1 percent and GST (TDS) WILL Be DEDUCTED FROM THE BILLOF THE

CONTRACTORS AS PER RULES.

7.The Intending tendering should possess a valid (A) Class electrical contractor license at the time of opening of tender issued by UPPWD & same should be uploaded along with e tender document by all bidders.

8.Bidder are Advised to submit EMD as PWD Rules.

9. All Work Will be carried out as per directed at site by Engineer In Charge in.

10.Bidders shall quote only those products in the bid which are not obsolete in the market and has at least one year residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this.

11.Generic Bidder are advised to check applicable GST on their own before quoting.Buyer will not take any.

12. Responsibility in this regards.GST reimbursement will be as per actual or as per applicable. Rates (whichever is lower), subject to the maximum of quoted GST%.

13. Shelf Life: The Product to be supplied must have minimum 5 Shelf Life.On the date of supply, minimum 5

14. Usable shelf life should be available/ balance

15. Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the Bid document ATC and Corrigendum if any.

16.Period of the supplied products shall be 4 month from the date of final acceptance of goods or after completion of Installation, commissioning & testing of goods (if included in the scope of supply), at consignee location GEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods.

17.The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established installation commissioning training, troubleshooting and maintenance service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

18.Warranty Timely servicing/rectification of defects during warranty period: After having been notified of the defects/service requirement during warranty period, Seller has to complete the required Service/Rectification within 5 days time limit. If the Seller fails to Complete service/rectification with defined time limit.

19.No advance payment release any case to contractor, all payment will be release after verification.

20.Right to Accept any bid and to reject any or all bids the department shall have right, not to accept the lowest bid and also to reject any or all bids or terminate the tendering process at any time, without assigning any reason, affidavit required from bidder.

21.Those bidders who have criminal record will not be able to participate in the tender process.

23.There may be deviation in the quantities as per the requirement of the site. For which the contractor will be bound. The payment for the work will be done according to the actual measurements at the site. The Contractor has to follow the rules of electric safety during work. Correction/Rectification of Defects/Complaints noticed during the Defect Liability Period within 48 Hours.

24.It will be mandatory for the Contractor to have GST related registration.

25.The Final bill of the work will be paid of the concerned firm only after the contractor has handed over the said work the concerned/consumer department/court.

26.Bidder should be registered in up PWD class A contractor for Electrical work.

27.As per pvd rule Emd should be submitted in hard copy before bid opening date.

28.Bank mandate is mandatory.

29.Bidder Must have Submit all Technician Aadhar card ,Local Adress and Electrical Safety Department issue /equivalent Technician/wireman Certificate Copy etc .
