Preamble</p> <p>A. All (Electric Cabling Service) Service contracts placed through GeM shall be governed by following set of Terms and Conditions:</p> <p>(i) General terms and conditions for Goods and Services;</p> <p>(ii) Service STC contained in this document;</p> <p>(iii) Product Specific STC of ...(Electric Cabling Service)... Service – as defined in Service Catalogue of the product which includes SLA for the Service for that particular product;</p> <p>(iv) BID / Reverse Auction specific ATC</p> <p>B. The above terms and conditions are in reverse order of precedence i.e. ATC supersedes Product Specific STC which supersedes Service STC which supersedes GTC – only in case of any conflicting provisions.</p> <p>C. The above set of conditions along with Scope of supply including price as enumerated in the Contract Document shall be construed to be part of the contract.</p> <p>D. This document represents a Special Terms and Conditions (“STC”) governing the contract between the Buyer and Service Provider. The purpose of this document is to outline the scope of work, Stakeholder’s obligation and terms and conditions of all services covered as mutually understood by the stakeholders.</p> <p>2. STAKEHOLDERS</p> <p>The main stakeholders associated with this STC are:</p> <p>i. Buyer</p> <p>ii. Service Provider</p> <p>The responsibilities and obligations of the stakeholders have been outlined in this document. The document also encompasses Service Level Agreement/ penalties in case of non-adherence to the defined terms and conditions. It is assumed that all stakeholders would have read and understood the same before signing the document.</p> <p>3. SERVICE SCOPE</p> <p>3.1 The Service Provider shall provide the following services:</p> <p>Point wise details (here about the scope, period of agreement etc.)</p> <p>The Scope of work will be according to Indian Standards code of practice for installation and maintenance of power cable and including 33 kv rating (I.S no. 1255.1983). This standard gives recommendations and broad guidelines for selection, transportation, Laying, jointing, termination, testing commissioning, maintenance and fault localization of power cables up to and including 33 kV ratings.</p>	

The scope of work covered in this tender shall be specifications, drawings, instructions, orders issued to the contractor from time to time during the work. It shall be the responsibility of the contractor to incorporate the changes that may be in this scope of work.

The service provider shall be fulfilling the following requirement as per the tender assigned –

- **GENERAL ELECTRICAL REQUIREMENTS**

The Contractor shall supply and install at his expense all secondary materials and special fittings found necessary to overcome the interference and to apply the modifications on the route of cables and conduits that are found necessary during the work to the complete satisfaction or the Engineer.

- **DRILLING & CUTTING**

- **TEST AND ADJUSTING**

- **Examination of the work**

3.2 Service Provider's obligations:

i. Point wise details (here about the obligations of the Service Provider).

1) Service Provider shall work in the site area only. They shall ensure that the allotted area and other facilities of the user/ Buyer are not misused in any manner by their staff/representatives. The Staff provided by the service provider should ensure that the working of the staff should be in discipline and follow the work ethics.

2) The service provider should be ensuring the safety of the workers.

3) The service provider should ensure the safety of the machinery during the installation of the cables

4) The service provider should be providing an expert individual/ team to coordinate with the buyer to update about day to day work or target to be achieved during the day, month.

5) The team or expert provided for the project should be having good years of experience in handling of the project and planning for the defined target to be achieved.

- The service provider shall be responsible for removal of all over-ground and underground structures (permanent, semi-permanent and temporary) and constructions from the site. The cost to be incurred in this regard shall be deemed to be included in the quoted rate of Bill of Quantities items and contractor shall not be entitled for any extra payment whatsoever, in this regard. The contractor, if required, shall demolish old structures on the proposed site, properly.
- The useful or precious material obtained from demolition of structures & services shall be the property of the Buyer and will be stored at the place specified by the Engineer- in-charge.
- The Contractor shall be responsible to co-ordinate with service provider/concerned authorities for cutting of trees, shifting of utilities and removal of encroachments etc. and making the site un-encumbered from the project construction area required for completion of work. This shall include initial and frequent follow up meetings/ actions/ discussions with each involved service provider/ concerned authorities. The contractor shall not be entitled for any additional compensation for delay in cutting of trees, shifting of utilities and removal of encroachments by the service provider/ concerned authorities.
- For shifting of drains, diversion of roads the service provider has to work for site clearance, enabling work, barricading at his own cost as per the direction of Engineer-Incharge and will be not entitled for any extra payment.

- The affected drain, road, underground pipes, telecommunication cables, OFC Cables or any other public property due to functioning of the project will be restored back by the service provider at his own cost.

3.3 Buyer's obligations:

About the obligations of the Buyer / Consignee

- The buyer will ensure the approach to the site via private land and clear the local mass problems if any. If any civil work is required for approach of machinery construction or clearance of approach road, the buyer will get it done.
- Buyer shall also nominate a site engineer from its organization to coordinate with Service Provider to set up the facility.

III. Buyer shall nominate store officer (department/unit/cell wise) who will hand over the material to be the authorized person of the Service Provider and also take back the same.

- The Buyer Department shall provide E-Way bill if needed to the Service Provider.

V. The Buyer Department should log complaint and inform the Service Provider as soon as they find any mal functioning or problem in services provided.

VI. Buyer shall nominate officer (department/unit/cell wise) to receive and verify the quality of Cable service. Such officers may be authorized to verify Service Provider's invoices / bills /claims and to issue receipts certificate (CRC) to enable the payment to the Service Provider.

VII. Buyer shall nominate officer (department/unit/cell wise) to verify the violation of any conditions of the service level agreement (SLA) and impose penalty/deduction if any from the Service Provider's claims.

VIII. Buyer will provide the suitable excavation and civil work.

IX. Buyer will provide suitable supports above or below the ground for erection of pipes.

Price Variation Clause:

"It is advisable to include Price Variation Clause in the long term contracts to take care of the increase/decrease in prices of various ingredients which majorly affect the overall price of the service. Buyers are therefore advised to include the Price Variation Clause (PVC) in the bid document through ATC for long term contracts. The additional payment, if any, on account of PVC can be done offline till such time online functionality is developed on GeM."

4. SPECIAL TERMS AND CONDITIONS

i. Point wise details of Special Terms and Conditions here.

ii. The Service Provider shall not carry and/or transmit any material, information, application details, equipment or any other goods/material in physical or electronic form, which are proprietary to or owned by buyer, out of Buyer premises without prior written permission from Buyer.

iii. Service Provider acknowledges that buyer's business data and other buyer's proprietary information or materials, whether developed by buyer's or being used by buyer pursuant to a license agreement with a third party (the foregoing collectively referred to herein as "proprietary information") are confidential and proprietary to buyer; and Service Provider agrees to use reasonable care to safeguard the proprietary information and to prevent the unauthorized use or disclosure thereof, which care shall not be less than that used by Service Provider to protect its own proprietary information. Service Provider recognizes that the goodwill of Buyer depends, among other things, upon Service Provider keeping such proprietary information confidential and that unauthorized disclosure of the same by Service Provider could damage buyer and by that reason of Service Provider's duties hereunder. Service Provider may come into possession of such proprietary information, even though

Service Provider does not take any direct part in or furnish the services performed for the creation of said proprietary information and shall limit access thereto to employees with a need to such access to perform the services required by this agreement. Service Provider shall use such information only for the purpose of performing the said services.

iv. Service Provider shall, upon termination of this agreement for any reason, or upon demand by buyer, whichever is earliest, return any and all material and information provided to Service Provider by buyer, including any copies or reproductions, both hardcopy and electronic.

v. Ownership and retention of Material: Buyer shall own the material, prepared by or for the Service Provider arising out of or in connection with this contract. Forthwith upon expiry or earlier termination of this contract and at any other time on demand by buyer, the Service Provider shall deliver to buyer all material and documents produced by or from or for the Service Provider in the course of performing the Services, unless otherwise directed in writing by buyer at no additional cost. The Service Provider shall not, without the prior written consent of buyer store, copy, distribute or retain any such material or Documents.

6. SERVICE LEVEL AGREEMENT/ SLA:

In case of non compliance of Service obligation, penalty per default will be imposed as per SLA and in case of ...three.. Consecutive defaults against same events, the contract will is be liable to be cancelled. However non delivery of product in time, not maintaining uptime, violation of existing laws and statutory requirements will be considered as a major default and the contract will be cancelled immediately without giving any further notice.
