2. Buyer Added Bid Specific Terms and Conditions-						
2.1 <i>Generic</i>						
OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.						
2.2 <i>Buyer Added Bid Specific ATC:</i>						
Buyer Added text based ATC clauses						
1) Please ensure to go through ATC document thoroughly. In case of any ambiguity or contradictions related to any of the provisions mentioned in ATC document, GeM bid document, GEM GTC, GAIL GPC etc., the provisions mentioned in the ATC document of this tender shall supersede and prevail over any other condition.						
2) Submit all Forms and Formats of the tender document duly filled, signed and stamped.						
3) After Award of Contract, in case of any variance in the terms and conditions between GE M contract and SAP PO/LOA, the terms and conditions of SAP PO/LOA shall prevail.						
4) MSE bidders participating in the tender should submit their UDYAM registration certificate <u>duly certified by Chartered Accountant and Notary Public with legal stamp.</u>						
5) <u>Technical specifications shall be strictly as per Section-VI of the Buyer Added Bid specific ATC document.</u> Bidders shall submit <u>SCC, Technical specifications sheets mentioned in the Sections - V, VI of the Buyer Added Bid Specific ATC document duly signed and stamped as acceptance.</u>						
6) Land-border Undertaking i.e., <u>Form-IA to Section II and Form-IB to Section II</u> in the page no. 18 and 19 of the Buyer Added Bid specific ATC document must be submitted duly filled, signed and stamped <u>on your company's letterhead.</u>						
7) Power of Attorney (PoA) on the name of the person signing the bid documents must be issued <u>on your company's letterhead.</u>						
8) <u>GST, PAN certificates and Aadhar Card of all the Directors/ Partners/Proprietor</u> of the co						

Company must be attached duly attested by Notary Public with legible stamp.

9) **Format F-10** in the page no. 93 of the Buyer Added Bid specific ATC document must be duly filled, signed and stamped on your company's letterhead.

10) All bidders are required to qualify the above BEC [Technical]. Bidders not meeting any of the above-mentioned criteria shall be rejected without assigning any reason. Bidders should ensure submission of complete information/documents in the first instance itself. Evaluation may be done based on the details so furnished without seeking any subsequent additional information/document. Only documents (Certificates, Purchase Order, Completion/Execution Certificate, proof of supply etc.) which have been referred/specified in the bid shall be considered in reply to queries during evaluation of Bids.

11) Pre-Bid Meeting shall take place on 12.03.2024 @11:00 A.M via online mode. Link to the meet is provided at 2.0 (F) of section I (IFB) of Buyer Added ATC document. Make sure to attend the same in order to get your queries related to the subject tender resolved.

12) Please make sure to submit the **EMD amount of Rs.1,52,542/-** along with the bid else, your bid shall be liable for rejection.

13) If any Bidder is associated with such a country that shares land border with India directly or indirectly, then such bidder has to provide the approval copy of being registered with the Competent authority without which the bid may be liable for rejection.

14) **EMD exemption** and MSE Purchase preference policies are applicable **only for the "Manufacturers of the Sodium Hypochlorite Solution"**. EMD exemption is not applicable to the Bidders participating as Authorized Dealer/Distributor even if the Bidder is an MSE. So, bidders have to submit the EMD amount accordingly and shall also submit the Valid Authorization Letter issued by the Manufacturer on Manufacturer's Letterhead.

15) All the **documents pertaining to Technical BEC shall be submitted duly certified by Chartered Engineer and attested by the Notary Public with legible stamp** else your bid may be liable for rejection without assigning any reason.

16) MSE and GeM splitting rule shall prevail over the said splitting clause. Subsequent to price bid opening and during the time of splitting of order quantity, options allowed by GeM portal for splitting of quantity shall be applicable and binding to the participant bidders.
