नियम और शर्तें | Terms and Conditions

1. General Terms and Conditions-

1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.

1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable

2. Buyer Added Bid Specific Terms and Conditions-

2.1 Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.

2.2 If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.

2.3 Make in india specific authorisation certificate needs to be enclosed.

2.4 Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2.5 Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

2.6 Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2.7 Generic

End User Certificate: Wherever Bidders are insisting for End User Certificate from the Buyer, same shall be provided in Buyer's standard format only.

2.8 Generic

Experience Criteria: The Bidder or its OEM (themselves or through reseller(s)) should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for 2 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

2.9 Generic

For hazardous chemical/item, all precautionary measure as per regulation from the point of transportation/ handling/ storage/ safety/ health/ environment to be undertaken/ specified before dispatch. During dispatch, proper symbol for the hazard/ MSDS/ Batch No./ date of manufacturing/ Gross Weight/ Net Weight/ shelf Life etc are to be written/ printed/ pasted on the body of the packing.

2.10 Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the QUANTITY to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2.12 *Generic.*

Products supplied shall be nontoxic and harmless to health. In the case of toxic materials, Material Safety Data Sheet may be furnished along with the material.

2.13 *OEM.*

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

2.14 *Scope of Supply.*

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2.15 *Certificates.*

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

2.16 *Buyer Added Bid Specific ATC.*

Additional Terms and Conditions

1. **Request for change/addition in quoted price/GST rates will not be entertained. If GST is not quoted the quoted rate will taken as inclusive of GST. If bidder fails to supply after being L1 firm, the firm will be blacklisted.**
2. **Prices quoted by the bidder shall remain firm and fixed during the currency of the Rate contract and not subject to variation on any account.**
3. **Quotations shall be strictly according to the required specifications and should upload the name of the manufacturer and the brand of the quoted items.**
4. **For Tablet/Capsule items, rate per each Tablet/Capsule should be quoted.**
5. **The Medicine & Drugs and other consumables should be of well known manufacturer/Brand. If require samples/documents for some of the items while in bidding process may be called for verification and should reach within 7 days from the date of letter issued to concern firms.**

Letter of Authorization from Manufacturer for the same and specific to the tender should be uploaded in the prescribed place. A brochure displaying clearly the product is to be attached with the tender if required.**
10. **Certificate of License of Drugs/Medicines wherever required such as under Narcotic Drugs and Psychotropic Substances Act (NDPS) and Rectified spirit and absolute alcohol etc. should also be submitted by bidders without fail, if quoted.**
