Contract Title: Consultancy Services to carry out a performance review of the Zimbabwe United Passenger Company (ZUPCO) and development of turn around strategies.

The Republic of Zimbabwe has received financing from the African Development Fund toward the cost of the Institutional Support for State Enterprises Reform Project (ISSER). The Government of Zimbabwe intends to apply part of the agreed amount for this grant to payments under the contract for **Consultancy Services to carry out a performance review of the Zimbabwe United Passenger Company (ZUPCO) and development of turn around strategies.**

The objective of this Performance Review shall include undertaking a detailed assessment of the Zimbabwe United Passenger Company (ZUPCO) governance and technical operating systems, processes and procedures in order to determine the possible quantified and time framed interventions by Government (in terms of governance, systems, capitalisation, etc) to improve on the Authority's performance in order for it to deliver on its mandate, vision and objectives in the most economic, efficient and effective way. The assignment is expected to be executed within four (4) months in three (3) phases within a six (6) month period.

The Government of Zimbabwe through the Ministry of Finance, Economic Development and Investment Promotion now invites eligible Consulting firms to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank *as specified in the Bank's [Procurement Framework](#), dated October 2015 and is open to all eligible bidders as defined in the Procurement Framework*, which is available on the Bank's website at <https://www.afdb.org/en/projects-and-operations/procurement/new-procurement-policy>.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Procurement Policy.
