Who is qualified to apply?

Interested parties should be:

- Local registered company who must be a duly registered entity with the Registrar of Companies or with the Registrar of Business Names, in which a copy of the Incorporation Certificate or Registration Certificate is to be submitted along with the Names of Shareholders and Directors or Names of Proprietor or Partners.
- Minimum three (3) years' experience relating to supply, installation, and repair of curtains for various residential properties such as houses, terraces, apartments, semi-detached houses, and flats.
Tenderers must be committed to adhere to **Local Business Development (LBD)** initiatives, namely having a minimum of **thirty percent (30%) local manpower** to be deployed on commencement date.
