The Scope of Works comprises of design, supply, delivery, installation, testing & commissioning, system cutover, training, documentation and rectification of defects during defects liability period for the signalling equipment including trackside signal and power cables, Voltage Limiting Devices (VLD), all necessary hardware and all associated cable accessories and materials for the restoration of Signalling System in Tin Wing Stop, Ginza Stop and Tin Yuet Stop.

Applicants shall note and make themselves aware of the Corporation's ethical and probity requirements which shall be applied throughout the tender and contract periods. Further, Applicants shall not, and shall ensure that its directors, employees, agents and sub-contractors shall not, offer or give any advantage as defined in the Prevention of Bribery Ordinance (Cap. 201) to any employee or agent of MTR Corporation Limited. Any breach or non-compliance with this paragraph by the Applicant shall, without affecting its liability for such breach or non-compliance, result in its application not being considered. Applicants shall not apply for prequalification as a single entity if you intend to act as a supplier, sub-contractor or sub-consultant for another entity who shall also apply for the prequalification, or if you are a partner in a joint venture established to seek prequalification for this Contract.

Companies having linkage to each other, e.g. subsidiaries, holding or sister companies, shall not apply for prequalification as a tenderer for the same contract, whether as a single entity or as a partner of a joint venture. "Sister company" shall mean all companies which are subsidiaries of or otherwise belonging to the same holding company. The existence of a holding-subsidary relationship shall be determined in accordance with the provisions in Sections 13 to 15 of the Companies Ordinance (Cap. 622) of Hong Kong. Companies having linkage to each other shall elect which company shall apply for prequalification.
