1. Tawaran adalah **TERHAD** dibuka kepada Syarikat-Syarikat / Pemborong-Pemborong yang mempunyai Lesen yang dikeluarkan oleh Pesuruhjaya Polis selaku Pegawai Melesen dan berdaftar di bawah kawalan Bahagian Pelesenan Agensi Pengawal Keselamatan (BPAPK), Pasukan Polis Diraja Brunei berdasarkan peruntukan Akta Agensi Keselamatan, Penggal 187 sahaja.

8. Tawaran yang diterima lewat dari tarikh dan masa yang telah ditetapkan tidak akan dilyan.
9. **Tarikh terakhir** mengambil dokumen tawaran adalah pada **5 Ogos 2024, Isnin jam 3.30 petang**
10. 10. Offers must be sent using the offer forms that have been prepared by  
The Ministry and the wholesaler / tenderer must fill out the forms completely, sign and stamp the company. Entries that are incomplete or do not follow the guidelines or rules will be rejected / canceled and the fees and documents will not be refunded.
11. Before the offer document is issued, each company is required to bring and present a copy of the Business Registration Certificate (Business Enactment Section 16 & 17) and is required to pay the offer fee at a predetermined rate.
12. Each offer form that has been filled in completely must include a copy of the Company's Business Registration Certificate (as stated in paragraph 11) together with a copy of the offer fee payment receipt (as stated in paragraph 5).
