**AMENDMENT NOTE/SPECIAL CONDITIONS OF CONTRACT AGREEMENT.**

The Rajasthan Transparency in Public procurement Act 2012 and Rajasthan Transparency in Public procurement Rules 2013 is applicable and The conditions of contract as per Appendix XI of Public Works Financial and Accounts Rules of Government of Rajasthan is attached with the Agreement with the following amendments/conditions.

In place of the Governor of State of Rajasthan or "The Governor of Rajasthan" wherever occurs in the said form, should be treated as replaced by "The Managing Director, Rajasthan Co-operative Dairy Federation Ltd." In place of the Government of Rajasthan wherever it occurs, should be read as "The Rajasthan Co-operative Dairy Federation Ltd." (RCDF Ltd.). In place of the Chief Engineer wherever it occurs, should be read as "The Managing Director, Rajasthan Cooperative Dairy Federation Limited".

The authorized Engineer or the Engineer Incharge wherever it occurs denotes the General Manager (DPM & Proj.), Rajasthan Co-operative Dairy Federation Limited, Jaipur. Specifications will mean the latest specifications approved by Public Works Department unless mentioned otherwise.

(i) Agreement Clause No. 1 is amended as under:-

"The security deposit @ 10% of the gross amount of the running bill shall be deducted from each running bill and shall be refunded as per rules on completion of the contract as per terms and conditions. The EMD/ BID SECURITY shall however be adjusted while deducting security deposit from the first running bill of the bidder. There will be no maximum limit of security deposit".

"All compensations or other sums of money payable by the Bidder to the Government under the terms of his contract may be deducted from or paid by the sale of a sufficient part of his Security Deposit, or from interest arising therefrom, or from any sums, which may be due or may become due to the Bidder by the Government on any account whatsoever, and in the event of his security deposit being reduced by reason of any such deductions or sale as aforesaid, the bidder shall within ten days thereafter, make good in cash, any sum of sums which may have been, deducted from or raised by sale of his security deposit or any part thereof".

(ii) Agreement Clause 43 stands amended as under:-

"The R.C.D.F. Ltd., shall have right to exercise proper quality control measures. The bidder shall provide all equipment and assistance to conduct such tests." Agreement Clause 43 A will remain as such.

(iii) Agreement Clause No. 45 & 45 A stands deleted.

(iv) In Agreement Clause No. 37(e) the Defect Liability Period (DLP) for civil works costing more than Rs. 10.00 lacs. shall be Five years as per the latest order of GoR.


(v) In Agreement Clause No. 37(e) the word "PWD" shall be replaced with "The RCDF Ltd.".

(vi) All contracts with RCDF Ltd; Jaipur shall require registration of workers under the Act, 1996 & extension of benefit to such workers under the Act. One percent cess, on this account is deductible over work order value.

(vii) The bidder should quote the rates in the prescribed Schedule 'G'/ Schedule 'H' only, unless otherwise the tender would be treated as cancelled.

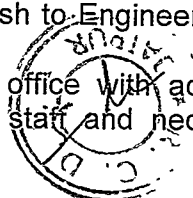

1. The bidder shall submit a construction schedule as to how he proposes to commence the work and there after shall complete various stages of the work within the time schedule given by the procuring entity for stage wise completion of the work.
2. The aggregates in general shall confirm to the specifications specified in MoRTH Specifications for Road & Bridge Works (Fifth revision) with recent addendum
3. Collection of material shall be uniform at plant and work site as per approved design mix and grading.
4. For construction of C.C. Pavement, the design mix report of the controlled concrete shall be got done from any Govt. Engineering College, PWD Laboratory or any NABL accredited laboratory. The same shall be submitted to the Engineer In Charge before commencement of the work for approval.
5. The Engineering in charge is empowered to check all privately hired/owned machinery & report, if any under specifications machinery is being used by the contractor. The same under specification machinery remove from site by contractor.
6. The contractor shall not work after the sunset and before sunrise without specific written permission of the Engineer-in-Charge.
7. Quality control record will be maintained as per I.R.C. Special Publication 11 with appropriate specific tests being carried out in the respective P.W.D. Regional Laboratory or in the field laboratory for which the cost will be borne by the contractor. In case, it is found that the results obtained for the work done are below the prescribed standards/norms, then the contractor has to remove such defective work at his own cost, otherwise it shall be got removed by the Engineer- in-Charge at the risk and cost of the contractor.
8. If any outsource test were required then all cost bear by the contractor himself.
9. Collection of all material and material to be used for road work as well as building works shall be subject to satisfactory test result of quality control before use. If test results are not found satisfactory, then the material shall be rejected and the contractor should remove all the unsatisfactory work had done and reconstruct the work up to the satisfaction of Engineer-in-charge at his own cost and the contractor shall be bound to it.
10. Fire fighting work also included in this work thus if contractor sub let the Fire work then Sub let contractor should have experience in Industrial fire safety. The contractor should get approval from engineering in charge in advance.
11. The contractor will display adequate number of Caution Boards/Diversion Boards for guidance of proper safety of traffic plying on the road.
12. The methodology and equipments to be used on the project shall be furnished by the contractor to the Engineer well in advance of commencement of work and approval of the Engineer is obtained prior to its adoption and use.
13. Compaction of earth in embankment or in subgrade shall be done by vibratory compactor to achieve the desired density as per specifications. For which no extra payment shall be made.
14. Monsoon period is included in completion period of the work.
15. Contractors is required to conduct surface evenness test by roughometer before and after completion of the work and furnish to Engineer-In-Charge in three soft and hard copies for record on his own cost.
16. Contractor will have to provide site office with adequate facilities, field and plant laboratory unit with qualified testing staff and necessary informatory boards/maps showing salient feature of the project.

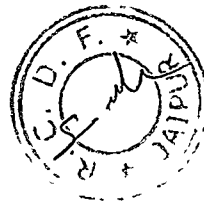

17. Force Majeure: The defect arises due to earthquake, cyclone, and natural calamities shall not be the responsibility of RCDF/CFP/Milk union.
18. Any damage to the structure including existing shall have to be rectified by contractor at his own cost under direction of Engineer-in-charge.
19. The Labour engaged by the Contractor for carrying out the work shall be at own risk and cost he is bound to protect the interest of Labour right as per Laws and Rules prevailing and enforce.
20. The final bill shall be paid after receipt of NOC from mining department.
21. Mixing of concrete shall be done by Automatic Batch Mix Plant (digitally controlled). Compaction of concrete shall be done by needle / plate / screed vibrators.
22. No equipment or personnel will be removed from site without permission of Engineer-in-charge.
23. Before starting of work/at the time of agreement, contractor shall submit to the Engineer In Charge for approval Program (Bar Chart) for execution of the work including Environmental Management Plan showing the general methods, arrangements, sequence and timing for all the activities in the works.
24. Prior approval of Electrical/ Sanitary items material should be got approved from Engineer – In – Charge. The construction material used as per specified make/ manufacturer as per Table -A contractor shall quote the rate accordingly for which no extra payment shall be paid as per BSR Items.

**Annexure 'A:- Compliance with the code of integrity and no conflict of Interest:**

The bidder will follow the code of integrity and no conflict of Interest as mentioned rule 80 and 81 respectively of RTPP Rules-2013 in case of breach of any provision of the code of integrity by a bidder or a prospective bidder as the case may be, the RCDF may take appropriate action in accordance with the provisions of sub-section (3) of section 11 and section 46 of RTPP Rules – 2013.

Any person participating in a procurement process shall –

- (a) Not offer any bribe, reward or gift or any material benefit either directly or indirectly in exchange for an unfair advantage in procurement process or to otherwise influence the procurement process;
- (b) Not misrepresent or omit that misleads or attempts to mislead so as to obtain a financial or other benefit or avoid an obligation;
- (c) Not indulge in any collusion, Bid rigging or anti-competitive behaviour to impair the transparency, fairness and progress of the procurement process;
- (d) Not misuse any information shared between the procuring Entity and the Bidders with an intent to gain unfair advantage in the procurement process;
- (e) Not indulge in any coercion including impairing or harming or threatening to do the same, directly or indirectly, to any party or to its property to influence the procurement process;
- (f) Not obstruct any investigation or audit of a procurement process;
- (g) Disclose conflict of interest, if any; and
- (h) Disclose any previous transgressions with any Entity in India or any other country during the last three years or any debarment by any other procuring entity.

**(1) Filing an appeal**

If any Bidder or prospective Bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First or Second Appellate Authority, as the case may be, as may be designated for the purpose, within a period of ten days from the date of such decision, action, or omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful in terms of section 27 of the Act, the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the technical Bid before the opening of the financial Bid, an appeal related to the matter of financial Bid may be filed only by a Bidder whose technical Bid is found to be acceptable.

(2) The officer to whom an appeal is filed under para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it of within thirty days from the date of the appeal.

(3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2) , or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the bidder or prospective bidder or the Procuring Entity , as the case may be, may file a second appeal to Second Appellate Authority specified in the bidding Document in this behalf within fifteen days from the expiry of the period specified in para(2) or the date of receipt of the order passed by the First Appellate Authority, as the case may be.

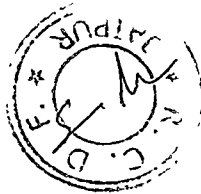
