The tenderer should quote the percentage rate of contract.

The contractor shall quote the price excluding GST and TCS (Tax Collection at Source)u/s 206C(1H) of the Income Tax Act 1961. The contractor should mandatorily specify the registration status, GST registration number along with the copy of GST registration certificate. **GST Registration status shall be furnished in the format attached and same shall be uploaded along with the bid. The contractor should not quote the GST rate, GST amount and TCS. Both GST registered and GST unregistered bidders can participate in this tender.**

Bidder should possess valid PAN Card and copy of the same shall be uploaded. The experience certificate for the similar works done shall be uploaded.

The successful bidder has to submit a copy of income tax return for the previous two years while submitting work bill for payment in order to avoid deduction of income tax at high rate.

Additional performance guarantee will be required if the works quoted between 11% to 25% below estimate rate.

All Communications shall be addressed to the Assistant Executive Engineer, Transmission Subdivision, Vaikom only. The Bid documents and other details may be downloaded from the website <u>www.etenders.kerala.gov.in</u>. Total amount of Rs. 47400/- (including the EMD of Rs. 19900/-and a non- refundable Tender submission fee of Rs. 5900/-) shall be remitted online to the account number given in the remittance form provided by the e-procurement system for this particular bid. Only NEFT/RTGS are allowed as mode of payment. In the event of award of contract to the successful bidder, at least 50% of the security deposit shall be remitted in the form Treasury fixed deposit and the same may be pledged in the name of Deputy Chief Engineer, Transmission Circle, Poovanthuruthu.

MSME registered bidders are exempted from remittance of cost of tender fees and EMD. Copy of the MSME registration with "Udyog Adhar registration" certificate shall be uploaded along with the bid otherwise tender will be rejected without further notice.

Insurance coverage certificate as per Workmen's Compensation Act 1923 (amended w.e.f 18.01.2010 and renamed as Employees Compensation Act 1923) for all the supervisors and workmen proposed to be engaged shall be produced. Original of the policy documents shall be submitted to this office before the execution of agreement. The name of work and work order Number shall be furnished in the insurance coverage certificate.

Tenderer should ensure that tender document fees and EMD are remitted as one single transaction and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transactions, and system will automatically reject the tender.

All the tender documents are to be submitted through online only and in the designated covers/envelopes on the above website. Tenders shall be accepted only through online mode in the website and no manual submission shall be entertained.

Scanned copy of the original bounden agreement (matter to be typed is attached to the tender form) shall be executed in Kerala Govt. stamp paper worth Rs.200/- and to be uploaded along with the bid at the time of online submission of the tender.
