
TERMS AND CONDITIONS

- I. All communications shall be addressed to The Executive Engineer Transmission Division Tirur, 110kV Substation Compound, Tirur Post-Pookkayil Bazar, Malappuram Dist, Pin-676107
- II. All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority. All communications regarding the tender including queries if any shall be done online at website <http://etenders.kerala.gov.in>.
- III. The bid documents and other details may be downloaded from the website www.etenders.kerala.gov.in. The **EMD of INR. 28,100/-**(Rupees Twenty Eight Thousand One Hundred only) and non-refundable bid submission fee of **Rs 5900-(Inclusive of GST @ 18%)**i.e., a total of INR. 34,000/-(Rupees Fifty Five Thousand Nine Hundred only)shall be remitted on line through internet banking . **Bidder should ensure that bid submission fees and EMD are remitted as one single transaction and not separate.** Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions. The online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.
