- I. All communications shall be addressed to The Executive Engineer Transmission Division Tirur, 110kV Substation Compound, Tirur Post-Pookkayil Bazar, Malappuram Dist, Pin-676107
- II. All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority. All communications regarding the tender including queries if any shall be done online at website <a href="http://etenders.kerala.gov.in">http://etenders.kerala.gov.in</a>.
- III. The bid documents and other details may be downloaded from the website www.etenders.kerala.gov.in. The EMD of INR.50000/-(Rupees Fifty Thousand only) and non-refundable bid submission fee of Rs 5900-(Inclusive of GST @ 18%) i.e., a total of INR. 55900/-(Rupees Fifty Five Thousand Nine Hundred only) shall be remitted on line through internet banking. Bidder should ensure that bid submission fees and EMD are remitted as one single transaction and not

**separate**. Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions. The online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.

- IV. The offers shall be submitted in Two Bid system.ie, Pre qualification Bid and Price Bid separately. All Bid documents are to be submitted online and in the designated covers/envelops on the above website. Bid shall be accepted only through online mode in the website and no manual submission shall be entertained.
- V. Opening of Bid- Cover no 1 technical bid consists of details of Tender Cost, EMD remitted, technical specifications, financial capability, experience and performance certificate as specified in tender document, scanned copy of Bid security, GST Registration etc. will be opened online. After verification of the contents of cover No. 1 i.e., technical bid opening, Cover No 2 ie. Price bid of the technically qualified bids will be opened. The bid shall be opened at this office in the presence of the bidders /their authorized representatives who wish to attend, on the date and time mentioned above or modified and communicated through corrigendum.
- VI. The scanned copies of EMD, all agreements executed in Kerala Govt. Stamp Paper worth Rs. 200/- in each and all certificates/documents mentioned elsewhere in the bid documents are to be attached along with the bid through online. - VII. After evaluation of the pre qualification documents, the technical evaluation committee will decide the qualified bidders and the bidders who are qualified will be intimated of the date and time of opening of the price bid.

After financial evaluation of the bid the successful bidder shall execute an agreement in the form prescribed by KSEBL for the due fulfillment of the contract within the period to be specified in the Work Order and shall furnish Security Deposit equal to 5% of the contract value before signing the agreement. Tenderers should be prepared to accept orders subject to an indemnity clause for forfeiture of security deposit in the event of default or failure to execute work within the stipulated period.
- IX. The rate quoted shall remain firm for six months from the date of opening of bid. The rate should be quoted as per format given in the E Tender portal.

- XVII. The bidder should have adequate financial and technical resources as well as infrastructures facilities readily available with him to undertake this work. The decision of the bidding authority will be final in acceptance of the bid if this condition is not complied with.
