2. All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority. More details about e- tendering procedure will be available from National Informatics Centre, Thiruvananthapuram on all working days from 10.30 am to 5.30 pm.

4. The Earnest Money Deposit (EMD) for an amount of Rs. 15,600/- and a non-refundable tender document fee of Rs. 1,534/- (including GST 18 %), total Rs.17,134/- (**Rupees Seventeen Thousand One Hundred and Thirty Four only**) shall be remitted online. The EMD and the non-refundable Tender document fee shall be remitted only online through **State Bank of India multi-option Payment System (SBI MOPS Gateway)** Bidder should ensure that tender document fee and EMD are remitted as one single transaction and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transaction. **The online payment may be exercised at least 48 hours before the closing date of the bid to timely reflect in the e-procurement system.**


